Ahadith of Makkan Period in Seerah Ibn Ishaq

Muhammad Ibn Ishaq (d. 150 H.) holds the position of an authority in Seerah writing. Not only in his own age but in every age as well he was considered the source of Seerah and he still is. The opinions of Muhaddithin, Ulama, Historians and Seerah writers about such a towering personality are almost negative and critical. In the field of Hadith he is not considered reliable and objections of sorts are levelled against him. In hadith narration he is called 'Mudallis'.

Ibn Hisham (d. 218 H.) compiled and precised the Seerah works of Ibn Ishaq. It gained popularity as Seerat Ibn Hisham. This book became so famous that the original book (of Ibn Ishaq) went in the background. In the Seerah narrations of Ibn Ishaq there are a large number of narrations which hold the position of Ahadith.
